Comments: The year of construction was verified as 1977 per Charlotte County Property Appraiser.

Comments: The roof covering was replaced in 2022. The roof permit was confirmed and the permit number is 20221259650. This roof was verified as meeting the building code requirements outlined on the mitigation affidavit.

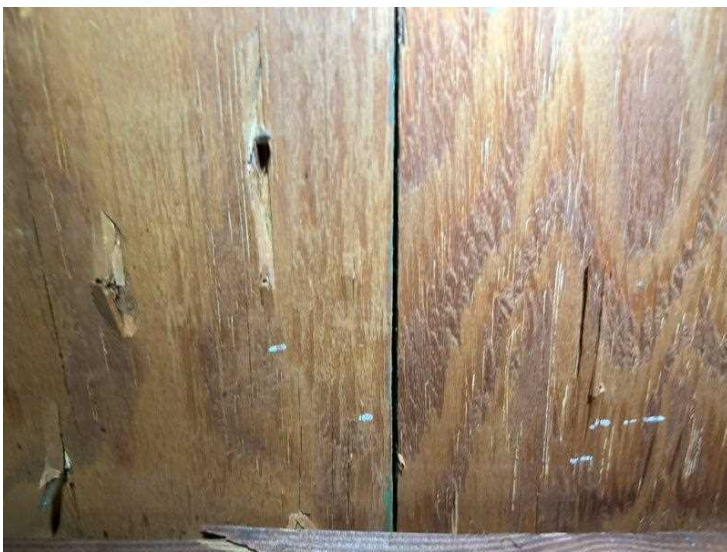
